 - Competitive follow-on to GS00Q14OADU324/47QFPA20F0020 (GSA OASIS)
 - **Scope:** Provide support to Networked Communications Resources (NCR) including Radio Frequency (RF) systems engineering research and development, integration, test and evaluation, sustainment; public-safety and highly interoperable communications systems; software development; enterprise-wide end-to-end integrated cybersecurity policy, operations and technical support; and implementing advantageous secure communication and architecture solutions for resilient and interoperable infrastructure, networks, platforms, and software.  - While many of these reqts are still “TBD” for the official Set Aside Designation, they are all follow-ons to existing Small Business Set Asides (or lower tier socioeconomic designations)
 - Corporate Experience and Workforce Pre-requisites to be utilized in the evaluation prior to Best Value Evaluation
 - Draft RFPs will be posted for each requirement – Industry will have ability to ask questions in regard to the Draft and Final RFPs
 - Donna Jackson is the primary PCO
